## Open Letter in respect of changes of Module Business

It is also agreed that to ensure the smooth transition of transaction and to avoid causing inconvenience to the customers, after Closing, SIMCom brand, team, products and business channels will remain unchanged. In addition, SIMCom wireless communication module products will be still manufactured in the Group factory and will continue to maintain its cost advantage and rapid delivery. Besides, the entire original team will join
